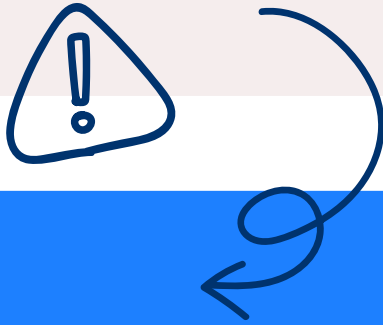

Headquartered in Newington, New Hampshire, the organization employs over **2,000 workers and operates a 140-acre academy** and experience center offering courses in self-defense, firearms and tactics.

Day-to-Day Challenges

After the organization signed a noteworthy contract with the US military, SIG Sauer experienced fast-paced growth.

This brought a number of challenges for the environment, health and safety (EHS) team, including an expanding workforce and corporate campus, new workplace regulations and new environmental, social and governance (ESG) concerns.

As Matthew Murphy, senior EHS supervisor, reports, the company's recent expansion into the ammunition market brought a **substantial increase in process safety regulations**.

For example, workers producing ammunition interacted regularly with energetics, which **posed a substantial safety risk** and required the involvement of a unique set of regulatory agencies.

Managing the increased flow of paperwork was difficult because of the EHS team's reliance on spreadsheets.

SIG Sauer's expansion also involved a significant increase in the need for environmental reporting. Tracking the use of chemicals monitored by the Environmental Protection Agency (EPA) as they passed through the company's facilities required the use of a highly governed reporting process. **The EHS team knew they needed a safety management solution** that could offer specialized knowledge and advice regarding EPA requirements.

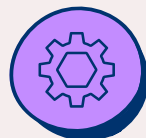
