Business challenge or opportunity	Benefits	Key stakeholders
Unplanned Downtime, Shutdown or Closure of Business	Reduce cost and production losses associated with disruptive events that have not been foreseen. EHS&S professionals spend a lot of their time preventing worst-case scenarios, such as fatalities. Technology can help outline these as the extreme events that need to be avoided. Regulatory Compliance	Reduce fines and penalties due to fewer violations of EHS&S rules and regulations, especially in a continually changing and evolving landscape.
